Safety Concerns

Nearly all of the senses are utilized when riding our marvels of engineering: Sight, smell, touch and hearing. A sense of perception and prediction needs to develop as well. Superman had X-Ray vision but sadly we don't. We can't see through that box truck waiting to to pull out of the side street or drive way. Our sense of perception and prediction should prepare us to expect that there is something on the other side of that truck and be ready to react if it pulls out in front of us. We can't see through that wall of rock to know what is around that curve in the road. There may be some boulders, loose gravel, a live or dead animal or even a disabled vehicle. We really have to be ready for anything and be prepared to take evasive action or apply the brakes. It is a mind game out there on the road. Most other drivers are usually courteous but some don't even see us. Ride as though none of them see us. Others view us as an enemy to be conquered. Let us take pity on those poor folks because they don't know what they are missing by not being a motorcyclist.

About Arizona helmet laws.

Everybody knows that Arizona has no helmet law. Right? In Arizona an adult with a motorcycle endorsement can legally rid on our streets and highways and can do so legally without wearing a helmet. True? Arizona is one of the states that allows bikers to make their own choices in terms of whether they wear a helmet as long as they are over 18. Correct? Well, as it turns out, not exactly. There is no helmet law regarding getting a traffic ticket, but there is a hidden helmet law that costs innocently injured bikers millions and allows at-fault drivers to get off the hook.

The court created a "case law," which means that it is still the law that must be followed, although it came from a court's ruling. That court stated: Our decision that evidence of helmet non-use is relevant to the issue whether a plaintiff could have avoided injuries and whether damages should be reduced accordingly does not lessen the free choice of a motorcyclist to use or not use a helmet. An adult may still, under existing law, freely decide not to wear a helmet. However, a helmetless rider who is injured and brings an action to recover in tort must bear the consequence of the free choice not to wear a helmet by reduction of damages in the amount the jury determines the helmet would have reduced the injuries.

Translated into plain English, the court found that people who admit driving negligently and admit that the negligence caused a serious head injury, can avoid paying any of the medical bills or other damages associated with the injury they cause. The court determined that this did not run contrary to the very helmet laws bikers all over Arizona rely on. So, the Arizona helmet laws say you cannot get a ticket. The "hidden helmet law" says you can have the money needed to provide compensation for a permanent injury or death taken away. The Arizona Motorcycle Law Guidbook.

This creative aesthetic and intense attention to detail is one of the main differences from other shows and sets the Handbuilt Show apart. This coupled with great music, fantastic food and beverage and a totally inclusive and welcoming staff make for a great weekend. From the motorcycles to the artists behind them, all have taken months and sometimes years to modify every detail and this event shows it all.

MPP - New Louisiana Law Exempts Motorcyclists From Anti-Masking Arrests



Motorcyclists in Louisiana score a big win! Efforts of motorcycle rights advocates paid off when the Louisiana legislature approved a law exempting "persons driving or riding a motorcycle" rom the state's anti-masking statute. (See Louisiana State Legisature-HB161)

The Louisiana House passed HB 161 on a vote of 95-0 on June ith, 2017 following a mass majority approval by the state Senate on May 30th, 2017. The legislation is on its way to the Governor's lesk.

The MPP reported in November of 2016, (See "Bikers Arrested or Wearing Bandanas", November 29, 2016) following a trip to ouisiana as a guest speaker at a Louisiana

Confederation of Clubs and Independents (LCOC&I) meeting, hat motorcyclists wearing legal helmets were being arrested for iolating a state "Anti-Masking Law" originally intended to deter



public acts of terror being committed by the KKK.

This obvious abuse of Louisiana statute was being used as a tool to profile and target motorcyclists, particularly in the Shreveport area.

The MPP provided a legislative proposal to Louisiana ABATE and the LCOC&I advocating an amendment to Louisiana's anti-masking law exempting individuals wearing state approved safety gear while riding their motorcycles for the 2017 session.

Louisiana motorcyclists followed through and successfully lobbied their legislators proving that grassroots political rights movements can be effective and achieve results very quickly when mobilized and organized. The MPP congratulates and commends these efforts because they serve as an example and a model for other states attempting to combat motorcycle profiling and discrimination in all of its various forms.






